SECTION 4: First aid measures

4.1. Description of first aid measures

General information

Remove and wash contaminated clothing before re-use. If you feel unwell, seek medical advice.

8.2. Exposure controls

Appropriate engineering controls

Ensure adequate ventilation, especially in confined areas.

Protective and hygiene measures

Use barrier skin cream.

Remove and wash contaminated clothing before re-use. Wash hands before breaks and at the end of workday. Avoid contact with skin, eyes and clothing. When using do not eat, drink or smoke.

Eye/face protection
